**On Approving the Charter of the State Procurement Agency Under the
Government of the Republic of Armenia**

In accordance with the Article 19, point 3 of the Law of the Republic of Armenia "On Procurement" and Decision # 531 of August 31, 2000 of the Government of the Republic of Armenia "On Priority Measures Ensuring the Enforcement of the Law of the Republic of Armenia "On Procurement" the Government of the Republic of Armenia decides:

1. To approve the Charter of the State Procurement Agency under the Government of the Republic of Armenia (is attached).
2. To assign the State Procurement Agency under the Government of the Republic of Armenia within a week's period to submit a proposal jointly with the Ministry of Finance and Economy of the Republic of Armenia:
 - a) to the Government of the Republic of Armenia about the maintenance expenses of the State Procurement Agency under the Government of the Republic of Armenia for September -- December, 2000;
 - b) to the Prime Minister of the Republic of Armenia about the structure, number of employees and salary rate for each position of the central staff of the State Procurement Agency under the Government of the Republic of Armenia.
3. This Decision enters into force from September 16, 2000.
