Кыргыз Республикасынын Министрлер Кабинетинин 2024-жылдын 27-августундагы № 518 "Коммерциялык эмес уюмдар жөнүндө" Кыргыз Республикасынын Мыйзамын ишке ашыруу боюнча чаралар жөнүндө" токтомуна ылайык, Кыргыз Республикасынын Министрлер Кабинетинин 2021-жылдын 5-мартындагы № 78 токтому менен бекитилген Кыргыз Республикасынын Юстиция министрлиги жөнүндө жобонун 13-пунктун жетекчиликке алып, **буйрук кылам:**

- 1. Төмөнкүлөр бекитилсин:

 - 2. Төмөнкүлөр белгиленсин:
- 1) чет өлкөлүк өкүлдүн функцияларын аткарып жаткан коммерциялык эмес уюмду Чет өлкөлүк өкүлдүн функцияларын аткарып жаткан коммерциялык эмес уюмдардын реестрине киргизүү негиз болуп, Кыргыз Республикасынын Министрлер Кабинетинин 2024-жылдын 27-августундагы № 518 "Коммерциялык эмес уюмдар жөнүндө" Кыргыз Республикасынын

Мыйзамын ишке ашыруу боюнча чаралар жөнүндө" токтому менен бекитилген Чет өлкөлүк өкүлдүн функцияларын аткарып жаткан коммерциялык эмес уюмдардын реестрин жүргүзүү жана алардын ишине текшерүү жүргүзүү тартиби жөнүндө Жобонун 24-пунктуна ылайык коммерциялык эмес уюмдун арызынын негизинде чыгарылуучу Кыргыз Республикасынын Юстиция министрлигинин буйругу саналат.

On Measures to Implement the Decree of the Cabinet of Ministers of the Kyrgyz Republic on Measures to Implement the Law of the Kyrgyz Republic on Non-Commercial Organizations No. 518 dated August 27, 2024

In accordance with the Law of the Kyrgyz Republic on Non-commercial Organizations, the Decree of the Cabinet of Ministers of the Kyrgyz Republic on Measures to Implement the Law of the Kyrgyz Republic on Non-commercial Organizations No. 518 dated August 27, 2024, and guided by the Regulations on the Ministry of Justice of the Kyrgyz Republic, paragraph 13, approved by the Resolution of the Cabinet of Ministers of the Kyrgyz Republic No. 78 dated March 5, 2021, **I hereby order:**

1. Approve:

- The Form of the Register of Non-Commercial Organizations Performing the Functions of a Foreign Representative, attached hereto in Annex 1 to this Order;
- The Application Form of a non-commercial organization performing the functions of a foreign representative requesting to be included in the Register of non-commercial organizations performing the functions of a foreign representative, in accordance with Annex 2 to this Order;
- The Application Form of a non-commercial organization performing the functions

of a foreign representative requesting to be excluded from the Register of noncommercial organizations performing the functions of a foreign representative, in accordance with Annex 3 to this Order;

- 2. Establish that:
- 1) Inclusion of a non-commercial organization performing the functions of a foreign representative into the Register of non-commercial organization performing the functions of a foreign representative shall be based on the Order of the Ministry of Justice of the Kyrgyz Republic issued following the application of a non-commercial organization performing the functions of a foreign representative requesting to be included into the Register of non-commercial organization performing the functions of a foreign representative pursuant to the Regulations on the Procedure for Maintaining the Register of Non-Commercial Organizations Performing the Functions of a Foreign Representative and for Inspecting their Activities, paragraph 24, approved by the Decree of the Cabinet of Ministers of the Kyrgyz Republic on Measures to Implement the Law of the Kyrgyz Republic on Non-Commercial Organizations No. 518 of August 27, 2024;
- 2) The grounds for excluding a non-commercial organization performing the functions of a foreign representative from the Register of non-commercial organizations performing the functions of a foreign representative shall be:
 - Termination of the non-commercial organization activity in accordance with the procedure established by the law of the Kyrgyz Republic;
 - The Order of the Ministry of Justice of the Kyrgyz Republic issued following the application a non-commercial organization performing the functions of a foreign representative requesting to be excluded into the Register of non-commercial organization performing the functions of a foreign representative, and based on the data verification conducted in accordance with the above Regulation, paragraph 27.
 - 3. The Public Information and Legal Education Department of the Ministry of Justice of the Kyrgyz Republic shall publish this Order on the official website of the Ministry of Justice of the Kyrgyz Republic.
 - 4. This Order shall come into force from the date of its publication on the official website of the Ministry of Justice of the Kyrgyz Republic.
