Türkmenistanda maýyplary döwlet tarapyndan goldamagy üpjün etmek maksady bilen, **karar edýärim**:

1. Görüş boýunça I derejeli maýyplary telefon üçin abonent töleglerini tölemekden boşatmaly we görüş boýunça II derejeli maýyplara 50 göterim indirim bellemeli.
