MINISTERIAL RESOLUTION NO. 538 OF 1994

The Minister of Labour and Social Affairs

* After examining the provisions of Federal Law No. 1 of 1972 concerning the powers and competencies of the ministers, and the amending laws to it;

And the provisions of Federal Law No. 6 of 1974 concerning associations for

public benefit;

And the provisions of Ministerial Resolution No. 348 of 1993 concerning licensing to collect money;

* And further to the submission made by the undersecretary of the Ministry for Social Affairs;

We have resolved as follows:

Article One

A new clause shall be added to Article 11 of Ministerial Resolution No. 348 of 1993 under No. 4, with the following wording:

- * In making a donation abroad, associations must comply with the following:
 - 1. That the donation or financial support provided by the associations should be made though the Red Crescent Association in this country or through those bodies which are designated by the official authorities in another country.
 - 2. The donations made to associations operating in the Arab Republic of Egypt must be made through the Ministry of Social Affairs in Egypt.

Article Two

This Resolution shall come into effect from the date it is issued and published in the Official Gazette.
